ABOUT ROHINGYA HUMAN RIGHTS INITIATIVE

Rohingya Human Rights Initiative (ROHRIngya) is a local nongovernmental, non-profit organization formed by young Rohingya activists in New Delhi, India. It is registered at the government of India as a Public Charitable Trust on the 1st January 2017 under the registration no. 20 SR IIB.

We have committed to work with vision, passion, solidarity, hope, unity and perseverance. Our mission is to selflessly promote Human Rights of all human beings, especially people from Rohingya community and other disadvantaged minorities residing in Myanmar.

We are implementing all our projects, advocacy activities and interpretation services in accordance with the rules of law of India, as that is the country of registration of this organization.

Our main mission is to highlight violated Human Rights of minorities, especially of Rohingya community that is said to be the most persecuted community in the world. Our organization carries out its activities in India and monitors closely the conditions of Rohingyas all around the world as well as the recent developments in the Rohingya Refugee Crisis in Myanmar and Bangladesh.

ROHRIngya was formed as a result of continuous inhumane treatment, legal and social discrimination of the Rohingya people. The 1982 Citizenship Law deprived the Rohingyas and some other ethnic minorities of citizenship of Myanmar and imposed many restrictions on these communities. Since then, many military operations against Rohingya civilians took place in Rakhine State (former Arakan State) in Myanmar. Rohingya people have been deprived of their rights for decades. Following repeated violent incidents in Rakhine state, there is nowadays a record number of Rohingyas seeking a safe haven in neighboring countries, especially in Bangladesh, and a high number of IDPs (internally displaced persons) across whole Myanmar.

FOCUS AREAS



HUMAN RIGHTS

Human rights violations of the Rohingya are our primary concern and we have provided assistance to numerous individuals who have experienced traumatic situations and survived the genocide at the hands of military of Myanmar. We plan to grow further as a reliable institution in the future for addressing and providing timely action to human right abuses of the Rohingya community in Myanmar, Bangladesh and India. We promote the human rights of Rohingya in India directly through various programmes, spreading the awareness in the media and conferences, and indirectly by supporting partner initiatives in Bangladesh and Myanmar.

We have worked rigorously with local organizations, local authorities and legal bodies to provide legal aid for the active resolution of cases of detention, harassment, violence, child labor and abuse and forced labor.

ADVOCACY

Conferences:

The humanitarian crisis caused by escalating violence in Myanmar's Rakhine State is causing suffering on a catastrophic scale for the Rohingya community. Over 700,000 Rohingya have fled from Myanmar to Bangladesh since 25 August 2017. Thousands more reportedly remain stranded and in peril in Myanmar without the means to cross the border into Bangladesh. Refugees arriving in Bangladesh, mostly women and children are traumatized, and some have arrived with injuries caused by gunshots, shrapnel, fire and landmines. Humanitarian partners continue to scale up operations, but additional resources are urgently needed. The Rohingya Human Rights Initiative regularly issues press statements to news channels and newspapers to highlight the continuing human rights abuses in Myanmar and to generate support for greater action to help the Rohingya community there. We also organize conferences and run campaigns to draw attention to the plight of the Rohingya and partner with human rights organizations and other institutions towards this end.



EDUCATION AND CHILD PROTECTION

We have a partnership with the Rohingya Literacy Program (RLP), a non-profit initiative established by a group of Rohingya refugees living in Delhi. This humble voluntary initiative primarily aims to empower Rohingya refugees and improve their educational, physical, cultural, and socioeconomical and addresses their issues of concern living in Delhi. Recognizing education as the base for empowerment, the RLP focuses on educational empowerment of Rohingya refugees through awareness generation, academic counseling guidance and admission facilitation from the primary school level to the higher educational pursuits.





The RLP started a hostel program for vulnerable children and youth in December 2017 to enable them to continue further their education and started a scholarship program for vulnerable students to encourage primary and secondary education. As of December 2018, there is only one university student from the entire Rohingya community in India. The RLP aims to enable at least 20 Rohingya to attend each year by encouraging secondary education, providing scholarships and hostel facilities. In 2018, the hostel students were supported by the following organizations: the Rehbar Foundation provided monthly grocery items; the Welfare Group assisted with transportation, hostel maintenance costs and stationery; and the Rohingya Human Rights Initiative supported for daily food for 3 months.

The remaining funds for the hostel program were supported by several individuals including students, businessman, social workers etc. As a result, the facilitation of education of 15 Rohingya vulnerable secondary students was undertaken in a multidimensional way, through the provision of hostel accommodation, food, transportation, stationary and other essential requirements. A major achievement was the sponsorship of a student who appeared for board examinations in October 2018, the only student from the Rohingya community to do so.

YOUTH EMPOWEREMENT, SPORTS & CULTURE

The "ROHINGYA FOOTBALL CLUB INDIA" is a project implemented by ROHRIngya in partnership with LEHLEH Sport in different states of India. The project focuses on promotion of community belonging, self-esteem, social health and welfare benefits to Rohingyas residing in India through the formation of Rohingya football teams in different states of India and through the organisation of football trainings and football matches.

This project aims to find talented football players among Rohingya community and to give them a platform to develop their skills and progress to professional football. Moreover, we use sports to promote the peaceful coexistence of the Rohingya community with the locals in India. This project also helps to highlight the Rohingya issue in India and on the international level. Another major objective is to provide a positive outlook to the Rohingya youth who have undergone immense suffering.



We believe in motto "Sports towards Human Rights." The Rohingya Human Rights Initiative has been sponsoring the Rohingya Football club of India since 2016. The players are aged between 18 and 25 from Delhi, Hyderabad, Nuh and Jammu. They include students as well as those working as shopkeepers, ragpickers and at auto repair shops. Training sessions are organized to help them develop their abilities.



WOMEN EMPOWERMENT



The Women Empowerment Project has been developed for adolescent refugee girls, especially who are illiterate, to empower them to become agents for hope and change in the community.

This project enables vulnerable young girls to learn skills to earn income to provide for themselves and their families, learn to engage with topics such as human rights and to improve their basic literacy skills. The beneficiaries of our Program are invited to work as peer mobilizers with our organizations and build awareness on human rights issues, including on gender-based violence, with others in the community. Their efforts and participation in community matters creates a shift in power dynamics and endeavors to rebuild their lives in India.

EMERGENCY RELIEF

The humanitarian branch of the Rohingya Human Rights Initiative has provided proactive and timely responses to emergencies involving Rohingya refugees in India. In the year of 2018, we have responded to crises in Delhi and Haryana where entire camps of Rohingya refugees were burnt down. Fifty families in Delhi and 57 families in Haryana lost every belonging they had including their UNHCR refugee cards. Emergency relief was provided including shelter, food, water, clothes, ration, medical care, sanitation, stationaries for school going children and financial aid to re-establish

livelihoods.

We have also distributed urgently required winter clothes and blankets to various locations. Study materials for school going children and ration for vulnerable families from Haryana, Uttar Pradesh, Delhi and Hyderabad were also distributed.





TRAININGS

Human rights can only be achieved through an informed and continuing demand by people for their protection. Human rights education promotes values, beliefs and attitudes that encourage all individuals to uphold their own rights and those of others. It develops an understanding of everyone's common responsibility to make human rights a reality in each community. Human rights education constitutes an essential contribution to the long-term prevention of human rights abuses and represents an important investment in the endeavor to achieve a just society in which all human rights of all persons are valued and respected. Rohingya community representatives from different parts of India joined "Project Voice" that took place from 8th to 12th June 2018 in New Delhi. The main topic of this workshop was human rights and capacity building of Rohingya community in India. It provided its participants valuable information and skills including conducting interviews, gathering quantitative and qualitative data, analyze collected data and draw conclusion in order to prepare participants for organizing or joining development projects

RESEARCH AND PUBLICATION

The Rohingya Human Rights Initiative has published numerous number of research papers highlighting the situations and developments of Rohingya refugees in collaboration with local volunteers from various universities, institutions, media groups and human rights organizations like University of Delhi, Jamia Millia Islamia, Jawaharlal Nehru University, Delhi College of Photography, O.P. Jindal, Ashoka University, Al-Jazeera, BBC, CNN, Reuters, VOA, Times of India, Indian Express, Press TV, France TV, German TV etc.
